



Mortgage Call Report Requirements by State Agency

Under the requirements of the SAFE Act, all state mortgage licensees must submit a report of condition as required by NMLS. The NMLS Mortgage Call Report was developed by state regulators to meet that requirement and system functionality to submit the report is available. Companies must submit at least their application and origination activity information on a quarterly basis.

“MCR Requirement = Yes” – If you hold a license with “Yes” in this column, your company must submit the NMLS Mortgage Call Report.
“State Specific Supplemental Form Required” – If you hold a license with “Yes” in this column, your company must submit the SSSF.
